- it contains correctly entered IBAN (International Bank Number = international bank number) of the payee,
- control of fees „SHA“ (shared = the fees of sending bank pays payer, the fees of receiving bank pays payee),
- it doesn't contain any request on a special processing form,
- it is made only between the banks involved in the SEPA system and within the area formed by member states EHP and another countries, which have voluntarily acceded to SEPA rules (for example Switzerland, Monaco, and San Marino).

SEPA direct debit bank provides only to a EUR account.

**NON-STP surcharge is applied to every foreign payment except checks if:

- these are payments for which the recipient's IBAN is required (e.g. payments within the EU and EEA) or the name of the recipient, or other mandatory information required by the recipient's bank, or correspondence by the bank, while this information is not provided or is not provided correctly,
- these are payments for which the BIC (i.e. SWIFT address) of the recipient's bank is required, and at the same time the BIC of the recipient's bank will not be indicated (does not apply to SEPA payments) or will not be entered correctly (including SEPA payments),
- for payments within the EEA and in the currency of the EEA country, the client enters the fee management "BEN" (fee management will be changed by the Bank to "SHA")
