## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

## 1. What is this product?

### Type

An Over the Counter (OTC) derivative contract – FX Forward with Chance (Double Knock-Out)

### Objectives

FX Forward with Chance (Double Knock-Out) products are used for managing foreign currency risks.

An FX Forward with Chance (Double Knock-Out) is an agreement between two contracting parties (client/UniCredit Bank Czech Republic and Slovakia, a.s.) to exchange an agreed amount of one currency for another currency at an agreed fixed rate on an agreed future date.

In an FX Forward with Chance (Double Knock-Out), you buy an amount of a specific currency (e.g. CZK notional amount) and sell an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (strike rate) on an agreed future date (settlement date).

In addition, you will receive a compensation payment if the underlying spot rate (i.e. the price of the currency pair on the spot market):

- has not been trading at or below the lower barrier and at or above the upper barrier at anytime from the trade inception until the expiry of the option, and
- is trading at or above the strike rate at expiry of the option.

The compensation payment represents the difference in value between the CZK notional amount converted into the settlement currency (e.g. EUR) at the spot rate minus the CZK notional amount converted into the settlement currency at the strike rate at expiry date.

In addition, you might agree to pay a premium to the bank; in any case, you will not get back the premium you paid.

Sample product terms are set out below and are based on legally predefined or realistic assumptions and may not match your specific contract details, e.g. your specific notional amount, whether or not you will pay a premium, etc.

## 2. What are the risks and what could I get in return?

### Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

This product does not include any protection from future market performance so you could incur significant losses.

## 3. What happens if UniCredit Bank Czech Republic and Slovakia, a.s. is unable to pay out?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank Czech Republic and Slovakia, a.s. becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. In the case such early termination results in a claim of the counterparty against the credit institution, the decision of the resolution authority can lead to a partial or complete reduction of the principal amount of this claim or in a conversion of this claim into equity (shares or other types of equity).

If UniCredit Bank Czech Republic and Slovakia, a.s. does not fulfil its obligations connected with the product or is unable to pay, you can lose part of or the full payout or can suffer an unlimited loss. This product is not protected by any deposit guarantee scheme, legal or otherwise, or any other type of guarantee.

#### 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself for the recommended holding period. The figures assume a notional amount of CZK 250,000. The figures are estimates and may change in the future.

#### 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 Year

The recommended holding period is equal to the contractually agreed term. You are not entitled to terminate the product unilaterally before the end of the contractually agreed term. This does not apply in case you have contractually agreed with UniCredit Bank Czech Republic and Slovakia, a.s. that one party or both parties have the right to prematurely terminate this product upon notice to the other party and subject to a compensation payment (contractual early termination clause).
