You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

A Deposit with an embedded FX derivative element - FX Switch Deposit

Objectives

FX Switch Deposit products are used to enhance treasury returns.

An FX Switch Deposit is an agreement between two contracting parties (client/UniCredit Bank Czech Republic and Slovakia, a.s.) where the client invests an agreed investment amount of one currency (e.g. EUR investment amount) at an agreed fixed rate and for an agreed maturity date. The fixed rate is higher than the current market rate because it is directly related to the currency risk, arising from the potential repayment of the investment amount in another currency (e.g. USD switch amount).

At maturity, you will receive a fixed rate payment in the investment currency (e.g. fixed rate payment).

The possibilities for the repayment of the investment amount are as follows:

- (i) if at expiry date the spot rate (i.e. the price of the currency pair on the spot market) is above the strike rate, you will receive the agreed investment amount (e.g. EUR investment amount) on the maturity date.
- (ii) if at expiry date the spot rate is at or below the strike rate, you will receive the FX switch amount (e.g. USD switch amount) on the maturity date. The switch amount will be determined by dividing the EUR investment amount by the strike rate.

In addition, you might agree to pay a premium to the bank; in any case, you will not get back the premium you paid.

Sample product terms are set out below and are based on legally predefined or realistic assumptions and may not match your specific contract details, e.g. your specific notional amount, whether or not you will pay a premium, etc.

2. What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

3. What happens if UniCredit Bank Czech Republic and Slovakia, a.s. is unable to pay out?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank Czech Republic and Slovakia, a.s. becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. In the case such early termination results in a claim of the counterparty against the credit institution, the decision of the resolution authority can lead to a partial or complete reduction of the principal amount of this claim or in a conversion of this claim in to equity (shares or other types of equity).

If UniCredit Bank Czech Republic and Slovakia, a.s. does not fulfil its obligations connected with the product or is unable to pay, you can lose part of or the full payout or can suffer an unlimited loss.

4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself for the recommended holding period. The figures assume a notional amount of EUR 10,000. The figures are estimates and may change in the future.

The person selling you or advising you about this product may charge you other costs. 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 Year

The recommended holding period is equal to the contractually agreed term. You are not entitled to terminate the product unilaterally before the end of the contractually agreed term. This does not apply in case you have contractually agreed with UniCredit Bank Czech Republic and Slovakia, a.s. that one party or both parties have the right to prematurely terminate this product upon notice to the other party and subject to a compensation payment (contractual early termination clause).
